### NOTIFICATION

1. It is proposed to hold a selection for filling up the following post of Vigilance Assistant in the Vigilance department of RCF, Kapurthala. The post is ex-cadre tenure-based non-sensitive posts. No additional financial benefit will be granted to selected candidates in Vigilance Organization. He will be posted in the same grade as he hold in his parent cadre.
2. Applications of the volunteers should be duly filled up in the enclosed proforma (Annexure-I).
3. For this post, staff working in Level-05 as indicated below is eligible.

4. The details of the post, along with eligibility is as under:-



Applicants of L-04 will be considered if there is no suitable candidate available from L-05 & should have completed 03 years service as on date.

5. Wide Publicity of the above vacancy may kindly be given and this should also be displayed prominently on notice boards for information of the staff.
6. Controlling officers are requested to forward the applications of eligible and willing candidates after approval of Cadre Controlling Authority.
7. Duly completed applications in prescribed proforma must reach this office latest by 15.04.2026.
8. Applications for post mentioned at Para-04 may be forwarded for only those candidates who are not figured/figuring in any Vigilance/SPE cases.
9. Candidate should possess sufficient knowledge of Railway service (conduct) rules and Railway Servants (Discipline and Appeal) rules.
10. The selection to the post of Vigilance Assistant will comprise of viva-voce /APAR/credibility.
11. Persons working in one grade below i.e L-04, for which selection is to be conducted may be considered on special merit/flair for the work.
12. Candidate who is selected will be required to join immediately and will not be permitted to withdraw and refuse posting in Vigilance Department. Normal tenure of the post is 03 years extendable up to 05 years in individual cases on special merit. However, administration reserves the right to repatriate him to parent cadre without assigning any reason.
13. This post is ex-cadre and will not confer on selected candidate any claim for such post in preference to his seniors in his parent cadre after his repatriation.

14. Staff who have already served in Vigilance Deptt. are not eligible to apply. However, if they have completed a sufficient cooling-off period (minimum 02 years) as on 24.03.2026, thereafter they are also eligible to apply.

15. The lien of the staff will be maintained in parent cadre.
