An Applicant must verify that his/her application is actually submitted after payment is made, otherwise the claim of any applicant regarding his/her candidature will not be entertained.

10. **Essential documents to be uploaded** :

To support their application, the candidates must upload the following documents in the online portal before the last day of application; failure of the same will result in disqualification of the candidate. And any application for alteration of documents already uploaded by the candidate in the online portal should be made before the last date of application. Documents to be uploaded are:-

- (a) **Confirmation Order.**

- (b) **Joining Report/Service Book Entry showing date of joining the feeder post.**
- (c) **Certification by HoD or Cadre Authority.**

11. Disqualifications :

- (i) Particulars/Details to be mentioned in the application should be completely and correctly stated. Any application not specifying the required information or incomplete documents of a concerned candidate shall be liable to be rejected.
- (ii) **Any candidate who, on verification at any stage of the recruitment process, does not fulfil any of the eligibility conditions will be disqualified.**
- (iii) Canvassing (**Insawipui**) by a candidate directly or indirectly will disqualify his/her candidature.

12. If payment is to be done through UPI, it may be done using only the mobile number used for one time registration. Persons with disabilities are exempted from payment of application fees. Fees once paid is non-refundable under any circumstances.
